### Outcomes from June 2025 WFC Virtual Workshop

Earlier this year, the Canopy & Ember: Indigenous Women in Forestry and Wildland Fire planning team, in coordination with the Women's Forest Congress, held the "Advancing Women's Leadership in Forestry and Fire Management - A Tribal Perspective" workshop. This workshop built on the strong interest and need for supporting women in the field of tribal forestry, following the 47th Annual National Indian Timber Symposium in 2024. It was there that the inaugural Native Women & Allies in Forestry Luncheon created space for Native women within the sector to engage in discussions and connect with each other.

# What's Happening in the WFC Community?

Minoritized Genders in Natural Resources (MGNR), a student organization at Colorado State University, hosted their annual Minoritized Genders' Natural Resources Congress on April 16th, 2025, boasting over 70 attendees. MGNR's mission is to create a safe space within Warner College of Natural Resources at CSU where everyone is welcome. MGNR and this event were originally inspired by the national movement of the <a href="Women's Forest Congress">Women's Forest Congress</a>. This event brought together CSU students and local professionals to network, connect over shared identities, and learn more about what it means to be a minoritized gender in a natural resource field. A minoritized gender is any gender that's been historically marginalized or underrepresented in society, like women, nonbinary, or trans people. Students had the opportunity to connect with over 20 organizations that partnered with MNGR for this event. Then students and professionals gathered to hear from Parker McMullen Bushman, a trailblazer in the conservation and environmental movements.
